 - I. <u>Call to Order</u> The meeting was called to order at 4:00 p.m. by Professor Campbell.
 - II. <u>Public Comment</u> No public comment.
- III. <u>Approval of minutes from June 28, 2024, August 29, 2024</u> The minutes deferred due to discussion topic on the agenda.

<u>Meeting with Executive Vice President Jones to unpack the proposed equitable funding act</u> The committee met to discuss Adequate and Equitable Public University Funding. FBBC includes members from UIC, UIS, and UIUC that expressed their willingness to engage in discussion on issues that may arise concerning the current Adequate and Equitable Public University Funding State Initiative.

EVP Jones provided background on recent related events and discussions, noting that one negotiation session had already taken place, with at least four more planned. The sessions involve university presidents, vice presidents, government affairs, advocacy groups, interest groups, and unions. EVP Jones mentioned there is not an immediate need for faculty and senate input, but that such input would likely be sought around January.

EVP Jones shared two public domain documents with FBBC:

EVP Jones shared PowerPoint slides displaying graduation rates for various student groups. It was evident to FBBC that there is a more complex narrative regarding the increasing minority graduation rates within the UI System. EVP Jones further clarified that while the proposed calculations in the imitative might benefit UIS and negatively impact UIC and UIUC, the overall effect would be detrimental to the System as a whole, as funding is managed at the System-level.

FBBC requested the committee be kept informed of any future developments related to the initiative, including:

1. A possible timetable, especially for interactions and discussions with the three senates.

- 2. Any relevant materials for distribution to faculty and staff serving on the senates.
- 3. Information on personnel leading communication efforts and related messaging.

The committee emphasized the importance of keeping all three senates informed about the initiative to ensure any reactions are well-informed.
