#### I. Call to Order

Professor Jenkins called the meeting to order at 10:04 a.m.

## IV. Approval of the minutes from October 8-9, 2024

#### V. Remarks from USC Chair

Professor Jenkins mentioned the semester has been challenging and expressed appreciation to USC Members for their efforts.

VI. <u>Meeting with President Killeen and Executive Vice President Jones</u>
President Killeen joined from Urbana and EVP Jones joined through Zoom.

President Killeen reflected on the past year. Applications are up double digits, indicating the high demand for education from University of Illinois. Enrollment, research and reputation are also up. To quote Abraham Lincoln, "First put your feet in the right place and stand firm." It is important to be the solution space and continue to support student and faculty success. The search has begun for the UIUC Chancellor.

Great things are happening. Quantum is a 2-billion-dollar investment. Governor Pritzker has asked the University of Illinois to operate and manage the park. PsiQuantum will be the anchor tenant in the Illinois Quantum and Microelectronics Park (IQMP) which will be located at the former U.S. Steel South Works location. PsiQuantum has a path, they believe, to build the world's first utility quantum computer which would have a capacity of 1 million qubits. This is a huge expansion of computational units. IBM has also announced plans to participate. IBM is launching the National Center for Quantum Algorithms.

President Killeen mentioned this is a formative period with the construction cost on the 78 and the massive dropping costs on empty buildings in the loop. The appropriated capital funds for DPI will be used to retain and grow the presence in the loop at DPI North (200 S Wacker Dr, Chicago, IL). In addition, a wet lab is being considered which was previously costed out at the 78 due to the cost consideration. DPI South will be a DPI presence in the IQMP. This is where the arts and humanities would have a presence. A steering committee is being formed which includes faculty from all three universities to determine what DPI South will do.

EVP Jones provided an update on SG3965, the Adequate and Equitable Funding Formula for Public Universities Act. EVP Jones attended five of the six meetings held. This provided an opportunity to voice concerns about the components of the bill and request additional simulations be considered. The revenues generated by the university endowment should not be part of the universities resource profile since they are outlined for specific use by the donor. The dialogue continues, as other methods are considered to address equity issues in institutions. The meeting last week was cancelled. There are two meetings planned for January.

USC inquired on how an increase in state appropriation would be managed. EVP Jones explained that the Illinois Board of Higher Education would be charged with its own algorithm. There are concerns with this and other universities have expressed their concerns. This would also impact the University of Illinois Board of Trustees and how

they make their funding decisions.

USC inquired to the status of discussions about equitable student share. EVP Jones mentioned that concerns have been raised, but there has not been movement on the issue.

President Killeen recognized EVP Jones for his efforts to better understand the proposed funding formula. There is potential institutional liability. The proposed formula is not driven by outcomes, such as graduation. The formula is driven by incoming students. Access 2030 is all about outcomes and graduation rates. Looking at the past ten years, enrollments at other institutions have decreased by 24% while the enrollments at the University of Illinois have increased by 22%. There have been significant strides in opening the doors to black students with 700 more graduated per year than 10 years ago. President Killeen reminded USC that Abraham Lincoln's idea was to educate the people. The core of the mission will always be the students. Economically, the university offers a 15% return to the State of Illinois on each dollar.

Professor Jenkins inquired about the pressures felt by UIS, a regional public university, and asked how the University of Illinois System might address the challenges. President Killeen responded that UIS benefits from being part of the System. There is currently an effort to consider shared services. UIS does have some demographic challenges. Chancellor Gooch is working on some creative efforts out of state. There is currently more residence hall space than students need. President Killeen mentioned that the largest opportunity for UIS is India.

EVP Jones mentioned a review is underway to consider the expenditure side and if there is something that could be managed on behalf of UIS as a piece of UIC, UIUC or the System. The largest opportunity for UIS is to drive enrollment. A pilot is being extended where in-state residential tuition is being offered to shouldering counties. UIS has an opportunity with their large online education. One group who could benefit from UIS are those with some college and no degree. There is a lower faculty to student ratio at UIS.

USC inquired about the possibility of students working in Springfield like they do in Chicago. President Killeen agreed it could happen and mentioned the IIN Hub in Springfield. IIN has grown quickly. The President's Office wants to open doors and create opportunities. There has even been discussion around shared teaching. President Killeen mentioned that UIS is a gorgeous campus.

EVP Jones provided a brief update on Data Strategy and indicated a report would be available soon.

Meeting recessed for lunch at 12:09 p.m. and was reconvened at 1:01 p.m.

## VII. Meeting with Joe Barnes

Professor Jenkins welcomed Joe Barnes, Chief Digital Risk Officer, to the meeting.

Mr. Barnes provided insight into the exploration of recent technology to eliminate passwords from the university. The benefit would be to systemically reduce the

effectiveness and impact of increasing social engineering attacks being used against the university. Without passwords, it is difficult to obtain someone else's credentials. Mr. Barnes spoke about two options for authentication: 1) Yubikey (hardware authentication tool); 2) Phone app where a user's phone would send a unique string to authenticate.

Quantum computing has both benefits and risks. The biggest risk from a quantum standpoint is that once a quantum computer is working, there is concern of what could happen if it was in the hands of someone with malicious intent. Quantum can break encryption, and systems can be vulnerable. This would mean organizations need to switch to quantum proof encryption to protect data. Mr. Barnes suggested at the very least, sensitive data should be encrypted with AES256 Encryption.

Generative AI has passed the adoption rate of the internet and home personal computers. There have been successes in administrative duties. Organizations utilize Chatbots. If regulations are reduced on big tech, this could present risks to the organization. AI will be revisited as a "risk" in 2025.

USC discussed working with students to write in-class without the use of AI so they could use their critical thinking skills.

Professor Jenkins expressed appreciation to Mr. Barnes for attending.

The meeting recessed at 1:48 p.m. for committee meetings.
